

《Flight!Refund!Policy》 Is Air France compensation for cancellation?

Yes, **Air France does provide compensation for cancellations in certain cases**, depending on the reason for the cancellation, the route, and the applicable passenger rights regulations such as EU261/2004 which governs European flights +1-(877)»(738)»0274.
